PRIVACY ACT 1988**

Howlong Country Golf Club is subject to the Privacy Act 1988. The Club has a commitment to privacy and the safeguarding of information provided by you. Any personal information provided by you to the Club (eg name, address, contact details) will be protected.

The Club does not usually disclose your personal information to any other organization or person unless there is a legal requirement to do so. The Registered Clubs Act 1976 requires legally for clubs to display in a conspicuous place for at least 7 days the names and addresses of individuals proposed for memberships.

You have the right to access any personal information that the Club may hold about you, including a right to correction of your information.

The Club, for marketing purposes, to improve our services will use your personal information to provide you with the latest information about those services and any new related services and promotions.

**FINANCIAL YEAR**

76. The financial year of the Club shall commence on the first day of December and end on the last day of November in each year or such periods as having regard to the Act, the Board may determine.

**ENTRANCE FEES AND  
ANNUAL SUBSCRIPTION AND LEVIES**

31. Members' total subscriptions shall be paid annually and in advance. The time and manner of payment thereof and all other matters pertaining thereto not especially provided for by these Articles shall be as prescribed by the Board from time to time.
32. The entrance fee and subscription or payments payable by members of the Club shall be considered by the Board from time to time and any proposed changes shall be presented on the recommendation of the Board as an Ordinary resolution to a General Meeting of the members for ratification. Provided that the annual subscription payable by ordinary members shall be not less than two dollars or such other minimum subscription provided from time to time by the Registered Clubs Act.
- 33. Any candidate elected during the first ten (10) months of the financial year to any class of membership shall pay the full annual subscription. Any candidate elected during the last two (2) months of the financial year to any class of membership shall not be required to pay an annual subscription for the balance of that year but shall pay the following years subscription in advance.**
34. If the annual subscription or any part thereof of any member shall not be paid within a period of two (2) months from the date upon which it shall fall due for payment the Secretary shall give to the member in default seven (7) days written notice within which such entrance fee or subscription must be paid and if the same shall not have been paid within the time limited by such notice the defaulting member shall from that date be debarred from all privileges of membership and his name shall be removed from the register of members of the Club.
35. The Board shall have the power to make charges and levies on Ordinary members for general or special purposes.

**A.G.U. GOLF HANDICAPS – SPECIAL NOTE**

Please note that in making application for playing membership of the Club you acknowledge and accept that you will be subject to the Australian Golf Union handicapping system and your handicap may be reviewed in the absolute discretion of the General Committee/Board on the basis of any cards returned in any competition.

By making application to the Club you also expressly acknowledge and agree that you will have no right to make any representations to the handicapper before any decision is made to review your handicap and that there shall be no appeal whatsoever from any decision of the General Committee/Board in relation to a review of your handicap.”
